ORDINANCE NO. 02-2020

AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF COCOA, BREVARD
COUNTY, FLORIDA; AMENDING CHAP-
TER 8, ARTICLE III OF THE CITY CODE RE-
LATED TO THE DIAMOND SQUARE COM-
MUNITY REDEVELOPMENT AGENCY FOR
PURPOSES OF IMPLEMENTING THE
INTERLOCAL AGREEMENT BETWEEN THE
CITY, AGENCY AND BREVARD COUNTY;
PROVIDING FOR THE REPEAL OF PRIOR
INCONSISTENT ORDINANCES AND RESO-
LUTIONS, INCORPORATION INTO THE
CODE, SEVERABILITY, AND AN EFFEC-
TIVE DATE.
