Authorize the City Manager to make adjustments to the FY2025 budget as necessary. (24-553). (Community Services Director)

Ms. Neuterman explained at the May 28, 2024 City Council meeting, staff presented CDBG allocation estimates for the City of Cocoa. After the May 28th Council meeting, Staff received the allocation for Fiscal Year 2025. The estimated allocation presented at the May 28th meeting was \$128,609. The new allocation for CDBG funding for Fiscal Year 2025 is \$119,567. Additionally, at the May 28, 2024 Council meeting, it was noted that the HOME funds also decreased to \$63,294.02. The actual allocation after deducting the County's portion is \$63,255.47.

Staff is requesting Council approve the updated, proposed FY2024/2025 Action Plan, approve the plan for submission to HUD, and authorize the Mayor to sign all subsequent certifications and agreements.
