A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COCOA, FLORIDA, RENAMING COCOA CONSERVATION AREA HIKING TRAIL IN HONOR OF GREGG STOLL; PROVIDING AN EFFECTIVE DATE.

- WHEREAS, Section 2-9 of the City Code establishes the method and procedure for naming certain City buildings, streets and parks and such naming rights are solely vested in the City Council; and
- WHEREAS, Gregg Stoll is a long-standing community volunteer who was a graduate of Cocoa's first Citizens Academy in 2019 and was appointed by City Council in June 2020 to sit on the Space Coast Transportation Planning Organization's Citizens Advisory Committee; and
- **WHEREAS,** Mr. Stoll is a proud supporter of the Brevard Museum of History and Natural Science; and
- WHEREAS, Mr. Stoll volunteers to help maintain the conservation trails and gives guided tours; and
- WHEREAS, the City Council hereby acknowledges his commendable and selfless dedication and contributions to the City of Cocoa, it is a most fitting tribute to name the City of Cocoa's Conservation Area Hiking Trail in honor of Gregg Stoll; and
- WHEREAS, the City Council hereby bestows this naming honor upon Gregg Stoll with a sense of tremendous thankfulness and gratitude, and wishes to once again commend him for his tireless devotion and contributions to the Cocoa Community; and
- WHEREAS, the City Council has determined this Resolution is in the best interests of the City of Cocoa.
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COCOA, as follows:
- **SECTION 1. Recitals.** The foregoing recitals are hereby fully incorporated herein by this reference and are deemed a material part of this Resolution.
- **SECTION 2.** Renaming Cocoa Conservation Area. The City Council hereby renames Cocoa Conservation Area Hiking Trail in honor of Gregg Stoll and said park shall hereafter be known and referred to as the "Gregg Stoll Conservation Area Hiking Trail." City staff is hereby directed to acquire, install and maintain a permanent marker at Gregg Stoll Conservation Area Hiking Trail to appropriately reflect the naming honor bestowed on Gregg Stoll.
