
#### Parks and Recreation Background



- Recreation District 4 was established in 1961 to provide funding for recreational facilities and programs to the residents of Cocoa, Rockledge, and surrounding Unincorporated Brevard County.
- This was a State Legislative action to help address the gap in park and recreational areas within this area.
- Current Expired Maintenance Agreement (2011)
  - Currently operating under the terms of the Agreement
- Current Level of Service Exceeds the Comprehensive Plan Requirement
  - ➤ 1.25 acres per 1,000 population
  - Current Population 18,833= 23.54 acres of park space
  - City currently has 323.58 acres of park space






FY 22-23 District 4 Revenue by Jurisdiction

## Summary



- The failed referendum in early 2000s crippled the D4 Parks ability to fund capital and routine maintenance. Seeking other opportunities to fund capital would help lessen the burden on the D4 revenue.
  - These funding sources could be a bond, revisited referendum, or a parks impact fee for new developments.
- The Operations and Maintenance funding can only be increased by a revisited referendum related to the D4 mileage rate, higher property values, or an additional assessment related to parks. This would require support from the entire Administrative Area. If there was a steady contribution to capital needs outside of the D4 revenue, this would also provide additional funding towards Operations and Maintenance.

### **Summary**



- The City of Cocoa contributes approximately 19% of the District 4 revenue.
- The City of Cocoa receives approximately 36% of the total revenue.
- Historically, the Brevard County BOCC has further contributed general fund dollars beyond what District 4 is able to fund.

## Summary



- Based on an average of the cities included in the Cost Comparison Chart, the City should seek to fund approximately 30 employees with an annual budget of \$2,886,417. This would create a separate Parks and Recreation Department that would also absorb Leisure Services.
- Including the currently funded Leisure Services Staff (3 FTE and 5 PTE) a staffing need of 24.5 FTE is still needed. The Leisure Services Division is currently 37% vacant, even after citywide wage increases.
- The \$2,886,417 does not include the initial capital outlay that would be needed.
- The equipment cost is estimated at \$1.5-2.0M depending on the number of staff and there is an 18-24 month lead time on vehicles and equipment.

## City Council Parks Operation Direction

On April 24, 2024, Brevard Board of County Commissioners approved direction to staff regarding the proposed Interlocal Agreement with the City of Cocoa for the operation and maintenance of Cocoa parks with the following options:

- 1) Present the proposed Interlocal Agreement to the City of Cocoa as is for their approval by October 1, 2024.
- If the City does not approve the Interlocal Agreement by July 31, 2024, the County will notify the City that it will cease to maintain the City of Cocoa Parks on October 1, 2024, at the beginning of the fiscal year.



### Recommendation

- Staff recommends entering into the D4 Maintenance Agreement with the County.
- The City prioritize parks needs based on the Parks Infrastructure Plan.
- As part of the annual budget planning, the City could utilize unspent funding to help complete those initiatives.
