NOTICE is hereby given that the City of Cocoa, Florida, will hold a Public Hearing at 6:00 p.m. on Tuesday, September 12, 2023, in City Council Chambers, located at 65 Stone Street, in Cocoa, Florida.

The City Council will consider adopting a Tentative Millage Rate for the Fiscal Year commencing on October 1, 2023, and a Tentative Budget for the Fiscal Year commencing on October 1, 2023, and ending September 30, 2024, as follows:
