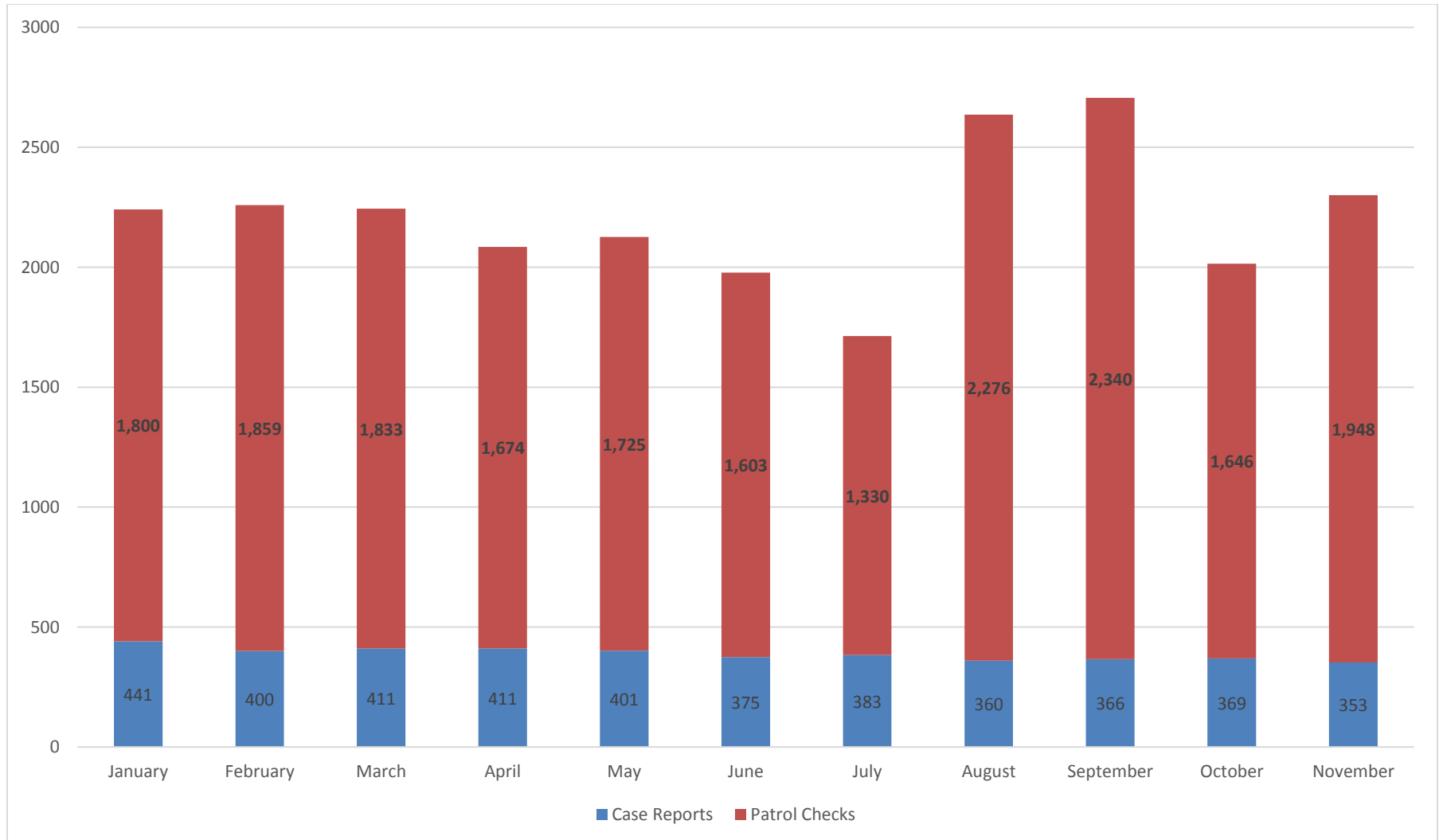

Findings Summary

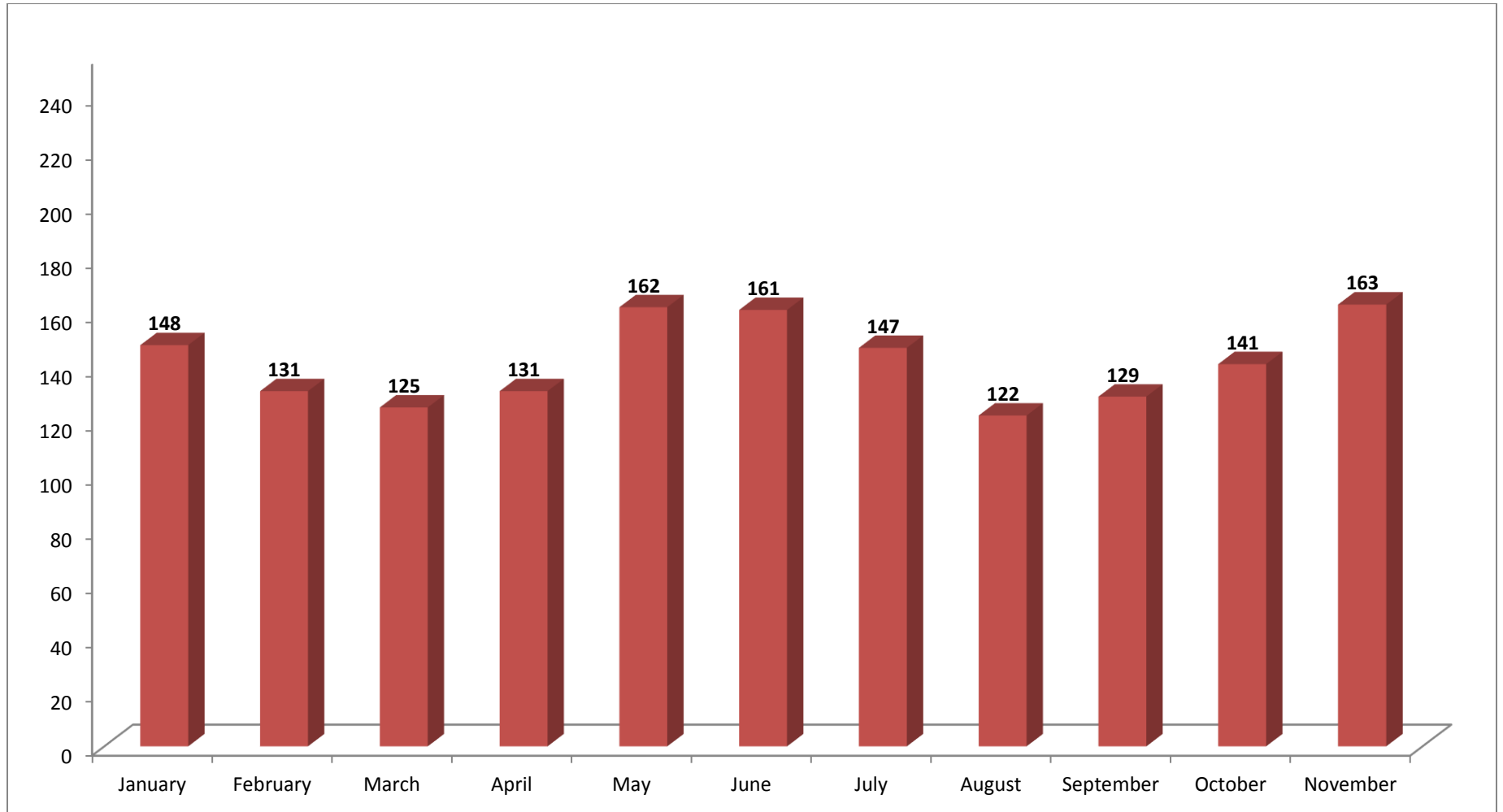
The purpose of this report is to provide the City Of Cocoa City Council with an overview of incidents and case reports for November 2019. This report includes a line graph illustrating the total number of UCR Offenses by month for years 2017, 2018 and 2019.

- 3,083 Incidents (Excluding Patrol Checks)
- 353 Case Reports (11% of incidents)
 - 183 Criminal Case Reports (51% of all case reports)
 - 170 Non-Criminal Case Reports (48% of case reports)
 - 70 Criminal Case Reports were closed by Arrests/Capias Requests (38% of criminal case reports)
 - 10 Non-Criminal Case Reports were closed by Arrests/Capias Request (6% of non-criminal cases reports)
- 2,289 Incidents were officer initiated (74%)
- District 1 generated the most cases with a total of 163.
- District 3 experienced the lowest amount of cases generated with a total of 32 cases.
- Aggravated Assault and Aggravated Stalking offenses have decreased by 25% from the previous month.
- Stolen Vehicle Offenses have decreased by 20% from the previous month.
- Lacey Offenses have decreased by 19% from the previous month.
- Overall, UCR offenses have decreased from the previous month by 15%.

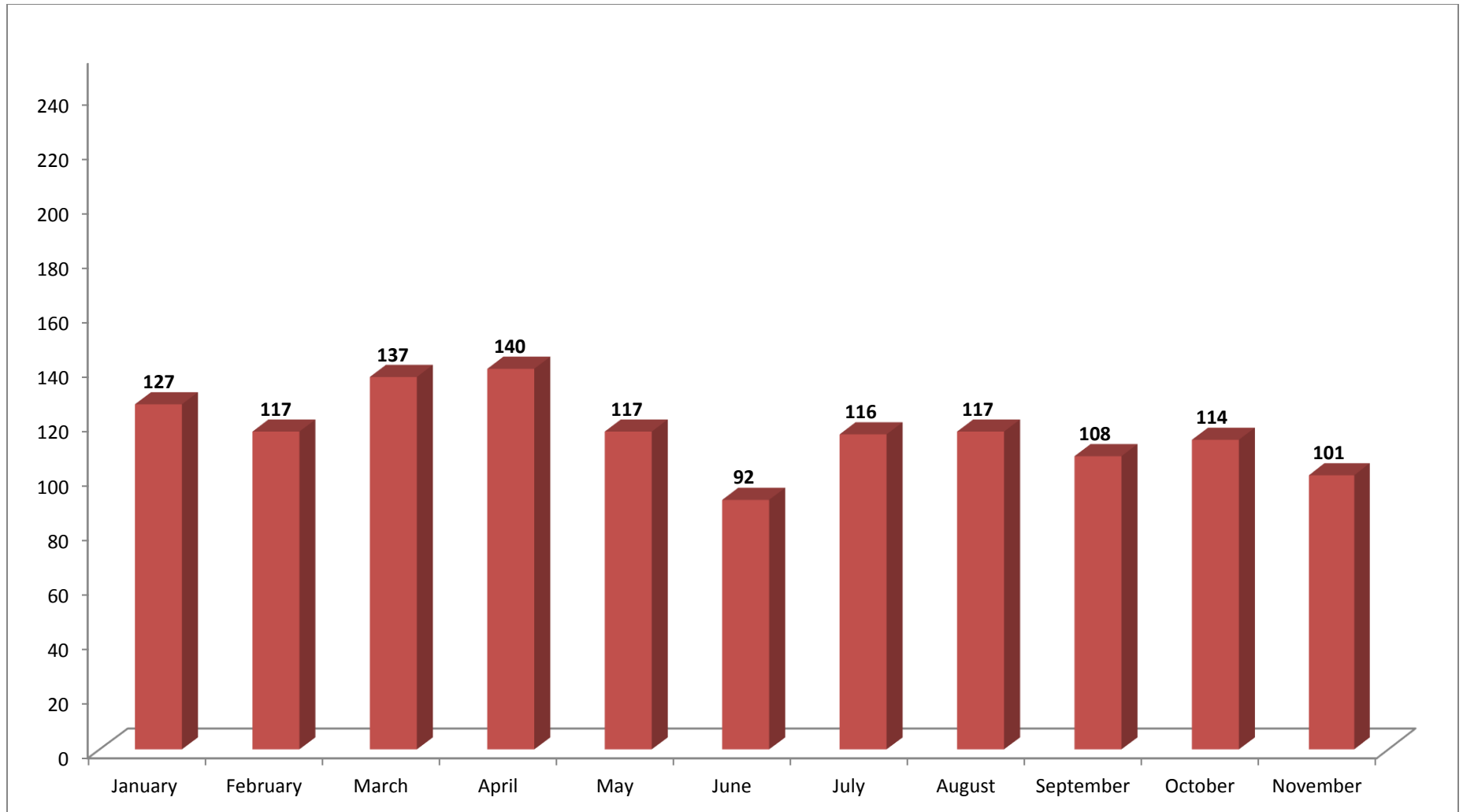

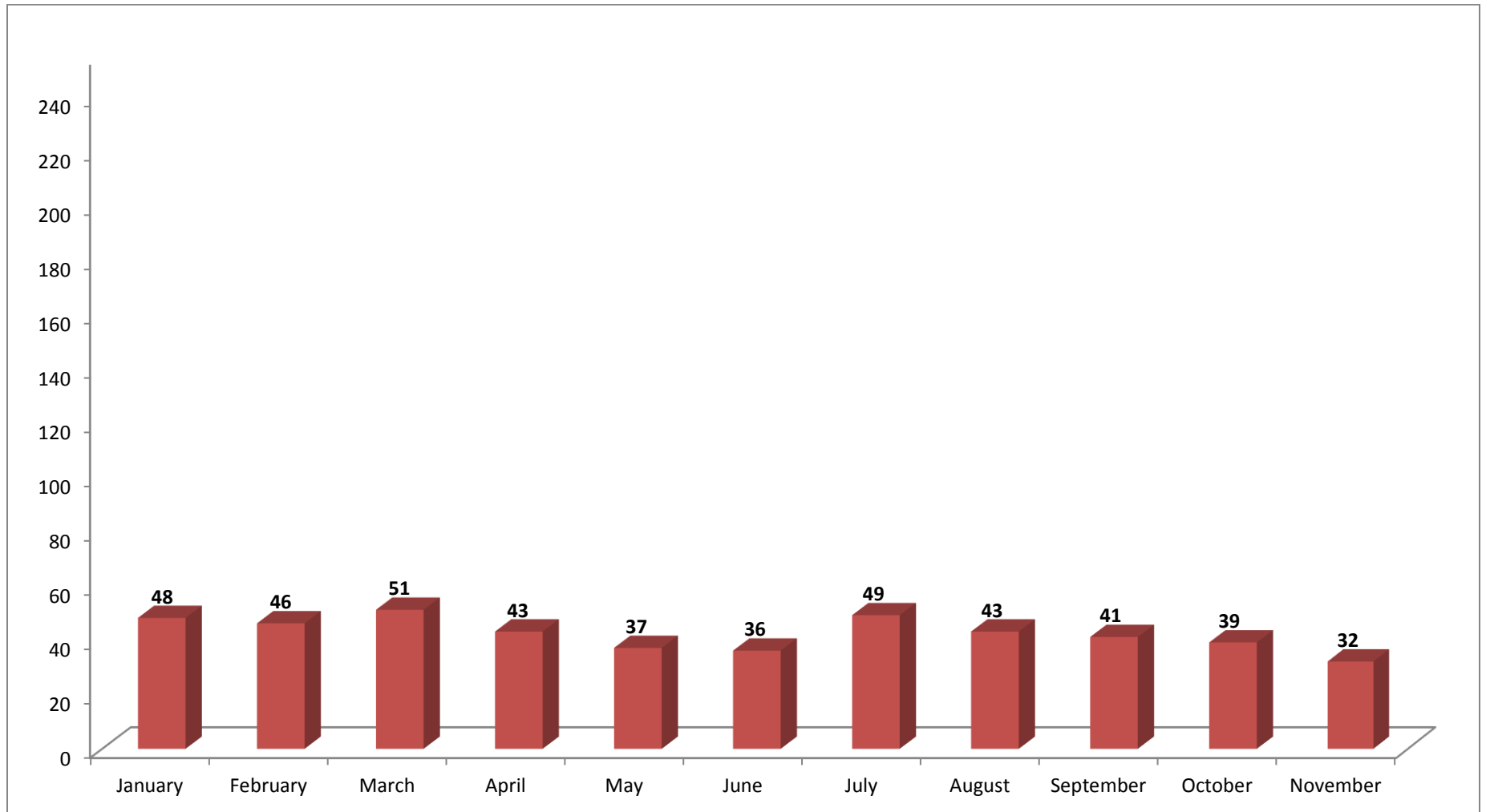

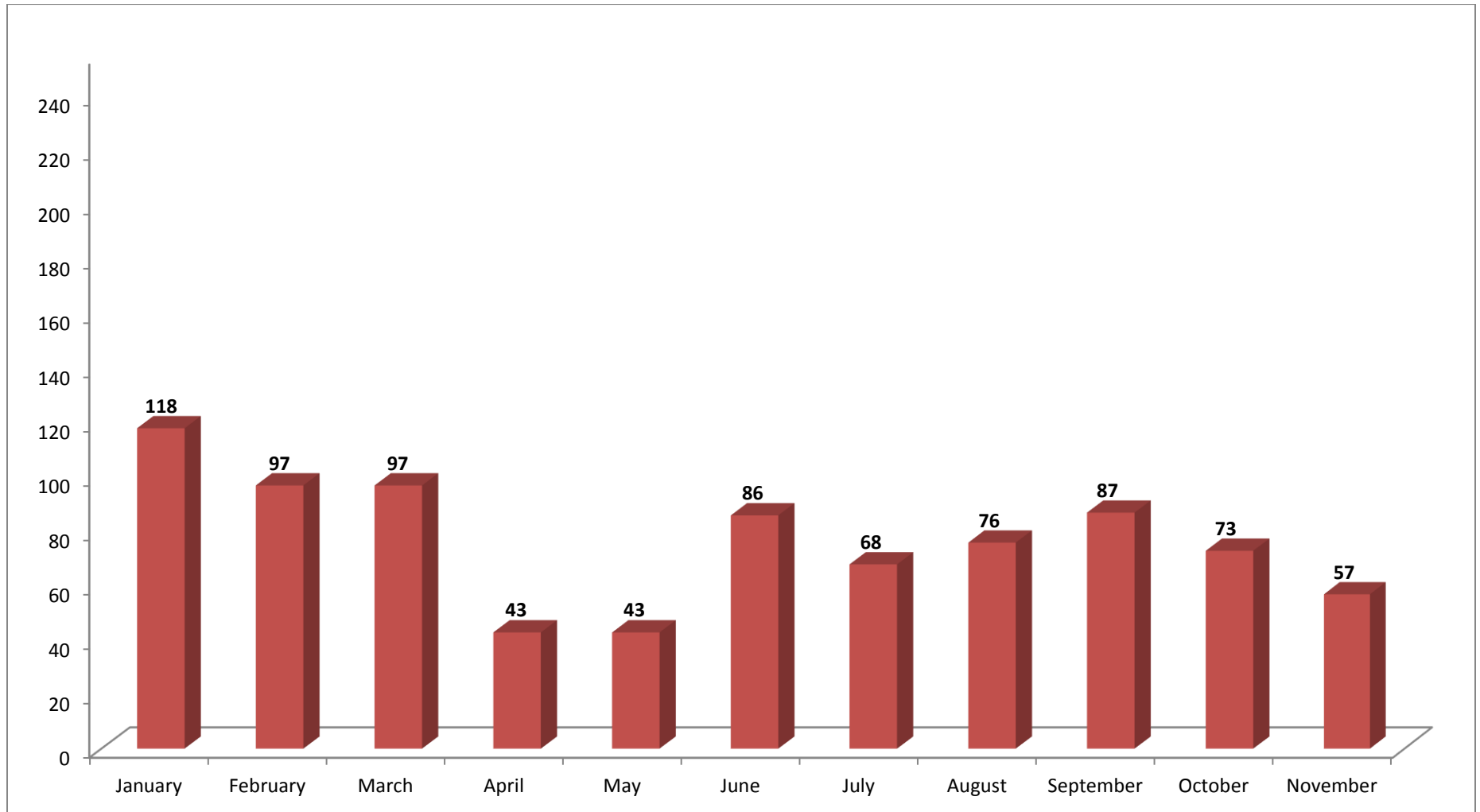

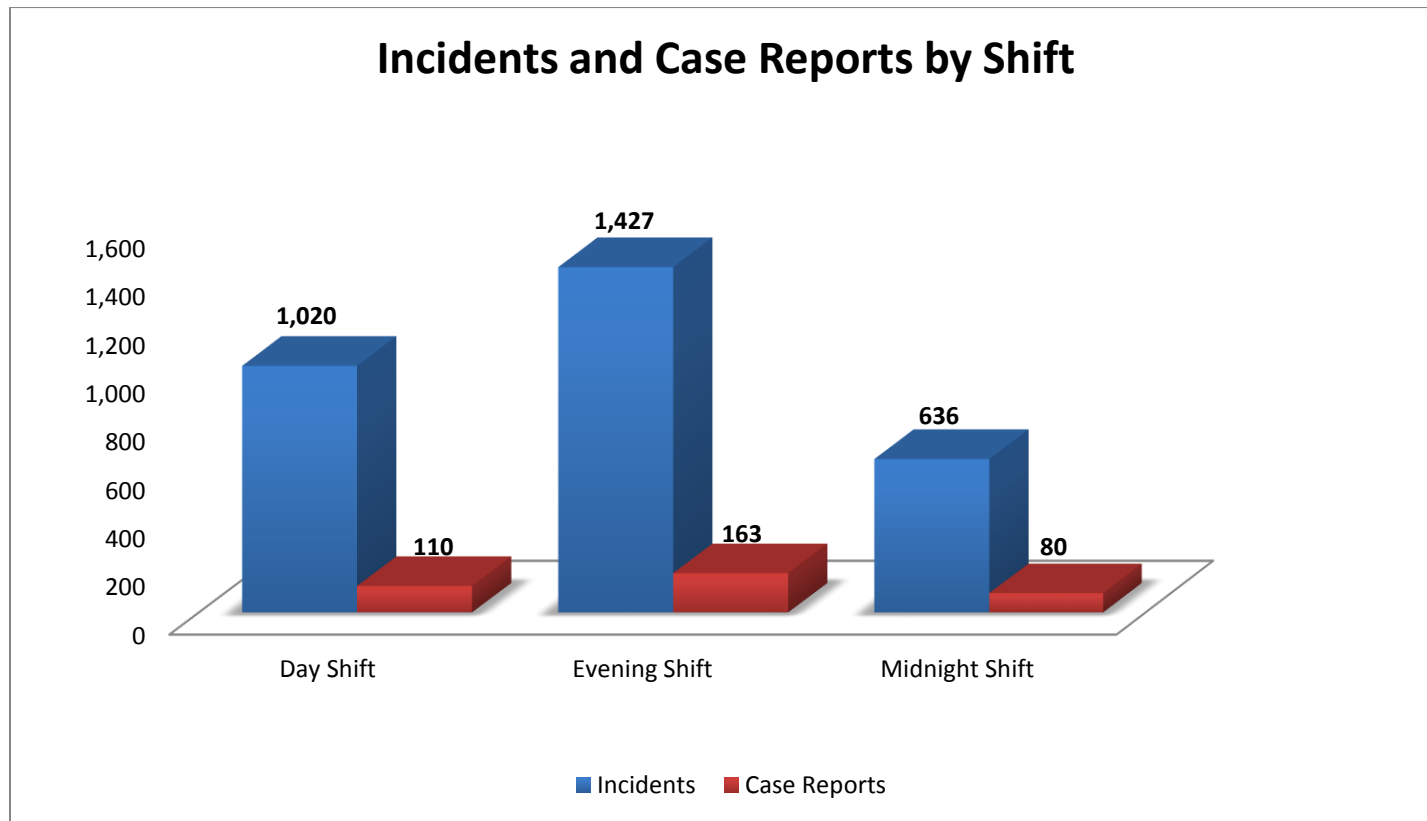
Locations of Incidents

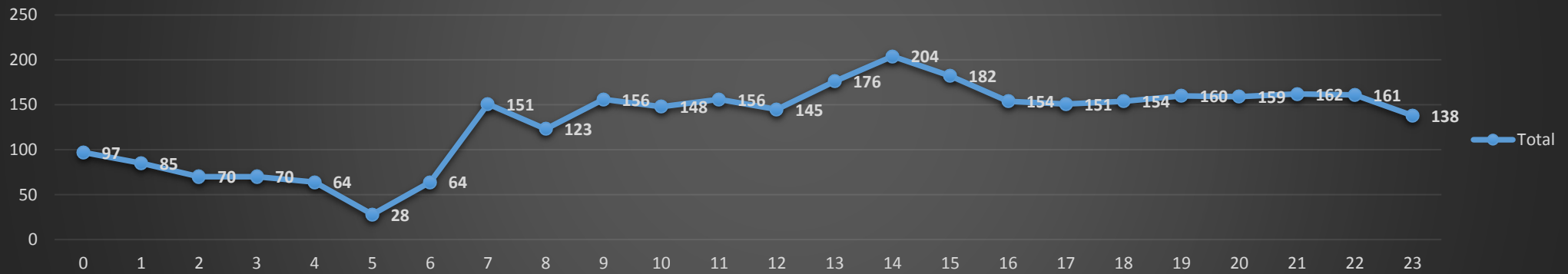

Note: The charts below illustrates incidents broken down by time of day. These totals do not reflect Patrol Checks.

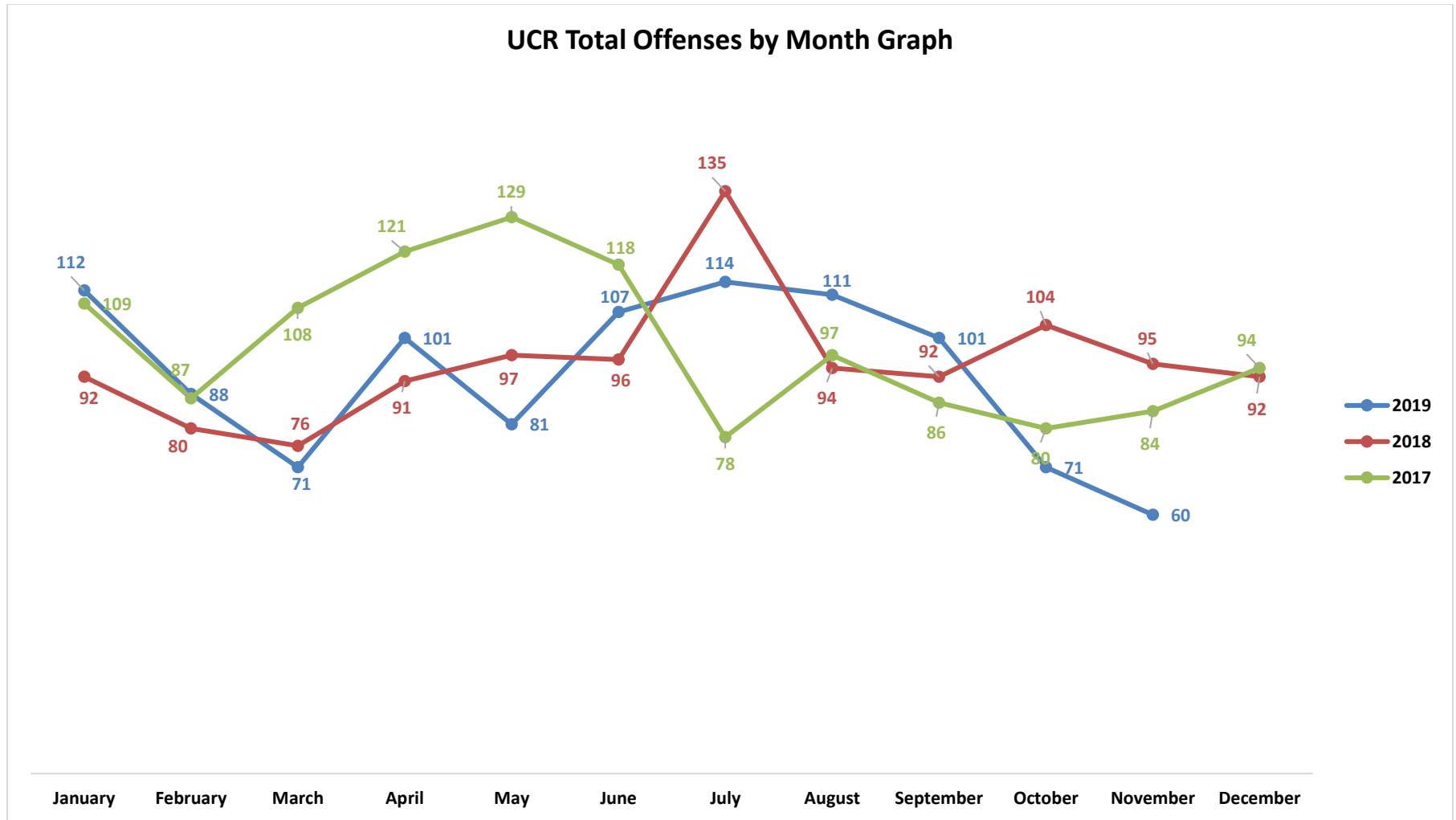
**November 2019 Incidents by Hour Totals
