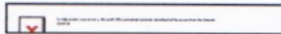

Meeting: City Council

Item: In accordance with the City Council's rules and procedures, residents or tax-payers of the City (upon any subject of general or public interest), City employees (regarding his/her employment), and water and sewer customers (on matters related to the City's water and/or sewer system), may address the City Council under Delegations on items not on the printed agenda by filling out a speaker card. Speaker cards are located outside the Council meeting room and should be provided to the City Clerk. Please observe the time limit of five (5) minutes while speaking under Delegations. Delegations shall be limited to thirty (30) minutes unless extended by Council.

eComment: The City Council was put on notice August 10, 2020 with Jake Williams violation of Charter separation of powers specifically prohibiting Mayor or any member of council from directing any city employee in performance of their job. In addition to his June 17, 2020 direction of Staffer he went so far as to present documents he claimed to be evidence of BACRAP and Larry Sinclair of fraud. In addition the City was noticed again that Williams is violating charter and should forfeit his seat for failing to live in City of Cocoa while serving. Video and photographic evidence was obtained by hiring of licensed Florida private investigator as well as Ron Parsons posting he lives on Tangerine St and so does Jake and affirms Williams is at that home daily. 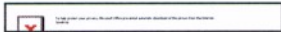

eComment: **From Bill Morris 1908 Manor Drive Cocoa-** I am in favor of mandatory mask wearing and urge you to vote yes. As of June 5, there were 107 cases in Cocoa. As of August 10, there are 676 cases, over a 6 fold increase in just 56 days. Deaths in Brevard County have gone from 15 to 152 during the same time period, a 10 fold increase in 56 days. We know there are 10 times more people infected with COVID than the above figures indicate. County ICU beds vary from 66% to 97% capacity. Things will worsen when schools open. If we do nothing COVID will infect half of Cocoa by the end of October. We know how to decrease these exponential rates. Please have the guts and the will to enact this proactive measure. It will save lives, reduce local hospital burden, and will have no impact on our economy. .

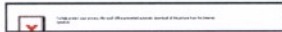

I'm not alone in my fear. The refrain "if you're scared, just stay home" doesn't take into account the fact that most of us don't have that option unless we're ok with living in the woods and scraping leftovers out of dumpsters. Some local citizens are now doing their shopping in Orlando because there's a mask ordinance there and they feel safer. Some have even been able to "temporarily" relocate to areas with mask ordinances and don't plan on coming back until it's safe. As long as we act like this pandemic is a hoax, why on earth should they come back? This means less money going to local businesses and fewer tax dollars in our coffers. We shouldn't ignore this. 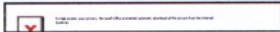
