## AMENDMENT TO PURCHASE AGREEMENT 3<sup>rd</sup> AMENDMENT BID NO. B-19-05-COC

This THIRD Amendment to the purchase agreement for Mowing & Maintenance of City Areas is made and entered into as of September 9<sup>th</sup>, 2020 by and between the City of Cocoa and US Lawns of Brevard, 374 Commerce Pkwy., Rockledge, Florida 32955.

The original agreement entered into on October 1, 2018, is hereby also amended to add the following additional service areas previously performed by the Florida Department of Corrections (FDC). Due to COVID-19, the services provided by FDC can no longer be provided at this time, which it is critical to continue ground maintenance of the areas specified in effort of overall upkeep and beautification of the City. The addition of these key areas has increased the original annual contract pricing by \$85,929.40. Upon City Council approve all parties agree herewith the additional changes to scope and pricing as proposed and scheduled to begin under said amendment effective October 1, 2020.

WHEREAS said extension Agreement will expire on September 30, 2020 and since both parties have agreed to exercise the SECOND of two optional renewals and thereby is warranted second and last extension effective October 1, 2020 through September 30, 2021.
