**October 13, 2020**

A Regular City Council Meeting was held on Wednesday, October 13, 2020, in Cocoa City Hall, in City Council Chambers, located at 65 Stone Street, in Cocoa, Florida, 32922, as publicly noticed.

**I. Opening Matters:**

Mayor Williams called the meeting to order at 6:03 p.m.

Mayor Williams introduced the new City Manager Stockton Whitten.

Chief Lamm provided the invocation and Deputy Mayor Goins led the assembly in the Pledge of Allegiance to the Flag of the United States of America.

**III. Awards and Presentations:**

1. Proclamation: National School Bus Safety Week. (20-694). (Deputy Mayor Goins)

Deputy Mayor Goins read the Proclamation into the record. The proclamation was presented to Mr. Ford and Dr. Mullins with the Brevard Public Schools.

2. Certificate of Recognition: Space Coast Recovery-Recipient of the Non-Profit Business Champion of the Year 2020 Award. (20-695). (Deputy Mayor Goins)

Deputy Mayor Goins presented Space Coast Recovery with a special recognition regarding their receipt of Non-Profit Business Champion of the Year 2020 Award. Barbie Thrower with Space Coast Recovery spoke and explained what their program entailed. He commended her and her staff for doing all that they do.

3. Presentation by Dr. Mark Mullins on the County's Half-Cent Sales Surtax. (20-670). (Dr. Mark Mullins, Superintendent, Brevard County Public Schools)

Dr. Mark Mullins, Superintendent with Brevard Public Schools, thanked Mr. Ford for his great work and service to the students of Brevard and thanked Council for the proclamation.

Dr. Mullins thanked Council for the partnerships with the City and Chief Cantaloupe for the SRO's.

He provided a presentation<sup>1</sup> regarding the Half-Cent Sales Tax and provided the ballot language for the upcoming election. Additionally, he provided a brief history on the tax and what it has been used for.

Due to this sales tax, schools are safer and there have been significant improvements such as technology, security, and air conditioning upgrades.

Dr. Mullins assured Council that the School Board would continue to provide complete transparency on what this tax will be used for.

In closing, he pointed out everything that the School Board was proud of but noted that in reality the surtax provides the environment that students need to learn in. Learning can happen in schools where students are equipped with the necessary means to get them to their future.

#### **IV. Delegations:**

Greg Stoll, 2203 Salem Drive, Cocoa, spoke in regards to the eagle's nest near the Adamson Creek subdivision. He noted that at the last meeting the issue of an undocumented eagle nest was brought up and thanked everyone for taking this issue seriously. He and his wife have recently completed training to become volunteers for Eagle Watch and asked D.R. Horton permission to watch the nest. He assured them that they would not interfere with the Adamson Creek improvements.

#### **V. Reports:**

Chief Lamm provided an update on COVID-19 and mentioned that the City was continuing to remain vigilant and follow CDC guidelines.

Ms. Gemmati pointed out that we received notice of the Florida League of Cities Legislative Conference which is being held on November 12-13, 2020 in Orlando and asked which Council members would like to attend. Deputy Mayor Goins

and Councilmember Koss would like to attend and Mayor Williams will attend if re-elected.

Assistant City Manager Fuhrer mentioned that they were finishing the new audio in Chambers and that representatives were in attendance tonight to make sure that the sound was working properly.

Councilmember Warner announced that the Annual Chris Daniel's Golf Tournament will be October 24, 2020 at 8 a.m. at Turtle Creek Golf Club. This will be the Chief's last tournament as the Chief of Police.

She further reminded all of the homicide that happened a few weeks ago in the City where former Councilmember James Wallen was killed by a burglar. The Police did an excellent job of catching the suspect but because of this incident there have been several neighborhood meetings. Several of the neighbors have discussed something that could be done for Mr. Wallen such as renaming the greenspace between Circle and Manor Drive in his honor.

She pointed out that Ms. Nancy Cabana was here to speak about how the neighbors would like to honor him.

Nancy Cabana, 1626 Manor Drive, Cocoa, thanked Councilmember Warner for setting this up. Ms. Cabana added that there were many who wanted to sign the petition but did not have a chance, as well as other ideas as to how they could honor Mr. Wallen. She spoke about issues with parking if it was to be named a park and that a tree planted in his memory was mentioned as well. Another idea was a plaque on a park bench but she believed that with all that Mr. Wallen did he deserves more than a plaque on a bench.

Mayor Williams stated that this was mentioned at one of the first neighborhood meetings and it was a nice gesture. He was in support of doing something he just did not want to create an area where a lot of traffic would be coming into the neighborhood.

Councilmember Warner explained the area in greater detail and asked that staff bring back to Council what the process would entail.

Deputy Mayor Goins voiced his appreciation to all of the citizens of Cocoa for coming together during all of the issues of 2020.

Councilmember Koss invited everyone to the District 4 Town Hall meeting being held on October 20 at 6 p.m. at the Brevard Museum of History and Natural Science on Michigan Avenue. There will also be a presentation on storm preparedness.

Councilmember Boisvert welcomed Chief Cantaloupe back and welcomed the new City Manager. He thanked all for attending the meeting tonight.

Mayor Williams thanked Mr. Fuhrer for all that he has done as Interim City Manager and that he stepped up when needed.

He mentioned the conduit on crosswalks in the Village so that trees that do not have power could have it as it would be nice to light up the Village like it used to be.

He thanked Council for the decision in regards to the police and bringing the salaries up to be competitive with other departments.

In closing, he welcomed Mr. Whitten again and was ready to continue moving the City forward.

Ms. Senger announced that this Saturday was the Dr. Joe Lee Smith Center Ribbon Cutting Ceremony at 10 a.m. Tours would be offered of the inside for anyone who wished to do that as well.

Deputy Mayor Goins commended Ms. Senger for the planning committee for this ribbon cutting and also for the work on the Census.

She pointed out that the Census could be taken until October 31<sup>st</sup> and that there were still two open seats in the upcoming Citizens Academy.

Attorney Garganese read Ordinance No. 15-2020 into the record, by title only as follows. He advised that this was the second and final reading of the ordinance.

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COCOA, BREVARD COUNTY, FLORIDA; AMENDING THE ADAMSON CREEK PLANNED UNIT DEVELOPMENT FINAL DEVELOPMENT PLAN FOR PHASE ONE-C; CHANGING THE ZONING MAP DESIGNATION OF ONE (1) PARCEL OF REAL PROPERTY, TOTALING 14.3 ACRES, MORE OR LESS, AND GENERALLY LOCATED DIRECTLY WEST OF I-95, IN COCOA, FLORIDA, MORE PARTICULARLY DEPICTED AND LEGALLY DESCRIBED ON EXHIBIT "1" ATTACHED HERETO, FROM BREVARD COUNTY G-U (GENERAL USE DISTRICT) TO CITY OF COCOA PUD (PLANNED UNIT DEVELOPMENT DISTRICT) AND INCORPORATING THE PARCEL INTO THE ADAMSON CREEK FINAL DEVELOPMENT PLAN FOR PHASE ONE-C; PROVIDING FOR THE REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, SEVERABILITY, AND AN EFFECTIVE DATE.**

Ms. Bunt provided an update on this ordinance and noted what it entailed and the amenities.

Mayor Williams opened the hearing to the public.

- Ana Saunders, with BSE Consultants, provided an update on items that were brought up at the last meeting. One issue was drainage of which there has been discussion regarding action to correct those issues. Additionally, DR Horton has mowed the lake bank between Lost Lakes and the subdivision. Signage was in fabrication and work to further improve drainage issues will occur when construction begins, as you cannot always determine exactly what the particular drainage issues are until you start working, however, they are aware of some of the issues already. Secondly, she spoke in regards to the eagle's nest and she advised that there are certain permitting criteria in regards to those which she discussed. This will allow access to phase 1C construction without any permitting issues.
- John Shepherd with Atlantic Residential, advised that it is currently breeding season for the eagles. They will go out certain times of the week while construction is going and look for behavioral issues. If you see any issue then you slow down the work. He was surprised to see two nests together but it is a positive because if there was a disturbance than they have a home nearby.

There being no further comments, the public portion of the hearing was closed.

(20-662). (Community Services Director)

Attorney Garganese read Ordinance No. 17-2020 into the record, by title only as follows. He advised that this was the first reading of the ordinance.

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COCOA, BREVARD COUNTY, FLORIDA, ADOPTING A LARGE SCALE COMPREHENSIVE PLAN TEXT AMENDMENT; AMENDING THE FUTURE LAND USE ELEMENT RELATED TO ALLOWABLE USES IN THE COMMERCIAL FUTURE LAND USE DESIGNATION; PROVIDING FOR THE REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, INCORPORATION INTO THE COMPREHENSIVE PLAN, SEVERABILITY,**

**AND AN EFFECTIVE DATE AND LEGAL STATUS OF THE PLAN AMENDMENT.**

Ms. Selig mentioned that Council recently approved Ordinance No. 11-2020 amending the Planning Unit Development zoning district regulations. This was intended to allow for mixed-use planning unit developments, in addition to other changes. The PUD code was originally written to provide a mechanism for the City to encourage and permit variation in development of residential and commercial projects; however, no provision was made for a mixed-use development pattern.

This ordinance provides greater flexibility in the development plan, allows for a mixed-use PUD form, revises the requirements for open space, and makes necessary revisions to the approval process for PUD's.

Mayor Williams opened the hearing to the public. There being no comments, the public portion of the hearing was closed.

4. Pass on 1st Reading: Ordinance No. 16-2020, of the City Council of the City of Cocoa, Brevard County, Florida; amending Appendix A, Zoning, Article V, the definition of Building Height. (20-671). (Community Services Director)

Attorney Garganese read Ordinance No. 16-2020 into the record, by title only as follows. He advised that this was the first reading of the ordinance.

**ORDINANCE NO. 16-2020**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COCOA, BREVARD COUNTY, FLORIDA; AMENDING APPENDIX A, ZONING, ARTICLE V OF THE CITY CODE RELATING TO THE DEFINITION OF BUILDING HEIGHT; PROVIDING FOR THE REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, INCORPORATION INTO THE CODE, SEVERABILITY, AND AN EFFECTIVE DATE.**

Ms. Selig explained that there have been a few multi-family projects come to the City in the last few years. She explained changes that have occurred with roofs through time. They are updating the Code without changing the intent of the original zoning limit.

Mayor Williams felt that these roofs were more aesthetically pleasing than a flat roof.

Councilmember Koss believed it was more than aesthetics as the intensity of rainfall has increased and the pitch helps the flow of the water, whereas it shortens the life of a flat roof.

Ms. Selig added that the Planning and Zoning Board recommended a change which was reflected in the recommended motion; however, the ordinance included with the item does not include that language.

Mayor Williams opened the hearing to the public. There being no comments, the public portion of the hearing was closed.

- \* **MOTION by Councilmember Boisvert; Seconded by Councilmember Koss, to approve Ordinance No. 16-2020, of the City Council of the City of Cocoa, Brevard County, Florida; amending Appendix A, Zoning, Article V, the definition of Building Height on First Reading.**

#### **VIII. Council Business:**

1. Approve the current Code Enforcement Lien for the property located at 1004 Montclair Rd., be reduced to \$1,379.29 as recommended by the Code Enforcement Board. (20-639). (Chief of Police)

Chief Cantaloupe provided a background on this case and advised that at the September Code Enforcement Board meeting the board was in agreement with staff's recommendation. There are no current code violations and all others are up to date.

- \* **MOTION by Councilmember Boisvert; Seconded by Councilmember Warner, to approve the current Code Enforcement Lien for the property located at 1004 Montclair Rd., be reduced to \$1,379.29 as recommended by the Code Enforcement Board.**

**THE MOTION CARRIED UNANIMOUSLY (5-0)**

2. Approve the current Code Enforcement Lien for the property located at 2406 Mercer Drive, be reduced to \$1,100.00 as recommended by the Code Enforcement Board. (20-641). (Chief of Police)

Chief Cantaloupe provided a background on this item and advised that it was taken to the September meeting of the Code Enforcement Board. The board was in agreement to reduce it to the requested amount and staff was in agreement as well.

- \* **MOTION by Councilmember Warner; Seconded by Councilmember Boisvert, to approve. The motion was opened for discussion.**

Councilmember Koss asked if the applicants know that there are liens on the property when they are asking for a reduction beyond what staff's recommendation was. She felt that this was a pretty good property and that the City was taking a hit on this one.

Chief Cantaloupe agreed and pointed out that Council has the ability to change to the amount.

Further discussion was held on the property.

3. Review State of Florida Executive Order Number 20-244 regarding Phase 3 of the Governor's Safe. Smart. Step-by-Step. Plan for Florida's Recovery and discuss future impacts to the local face covering emergency Ordinance no. 13-2020, Resolution 2020-146 expanding outdoor dining options, and safety plan approvals for special events at City facilities. (20-673). (Assistant City Manager)

Assistant City Manager Fuhrer reminded Council that on September 25, 2020 Governor DeSantis signed Executive Order No. 20-244 which moved the State of Florida into Phase 3 of the Safe. Smart. Step-by-Step. Plan which in turn, supersedes and eliminates any and all restrictions of previous Executive Orders issued for Phases 1 and 2.

As it relates to the City, staff now needs direction on the emergency ordinance requiring face coverings, social gatherings, and outdoor eating spaces.

He advised that the first thing to consider was the Emergency Ordinance regarding face coverings. The executive order does not restrict the City's ability to mandate but it does stop the City for being able to take fines. Staff needs approval to extend the ordinance for another thirty days.

Mayor Williams was in favor of continuing the ordinance for thirty days.

Deputy Mayor Goins felt that powers were being taken away and that people were relaxing because nothing can be done technically. He agreed on the extension of the ordinance.

Attorney Garganese felt it was important to point out this order does not suspend the imposition of a fine or penalty, just the collection. Theoretically, if a fine is given it could possibly be collected if this order is lifted.

Councilmember Warner believed that businesses are thankful for the pressure being taken off of them for requiring masks and that it should be left alone and extended.

Councilmember Koss would like the signs to be removed from parks.

- \* **MOTION by Councilmember Koss; Seconded by Councilmember Warner, to extend Ordinance No. 13-2020, Requiring Face Coverings for thirty days.**

**THE MOTION CARRIED UNANIMOUSLY (5-0)**

Assistant City Manager Fuhrer advised that the second item for Council to consider was related to Resolution No. 2020-146 for additional outdoor dining areas. This resolution has been rendered useless with the new order, which expands the capacity of restaurants to no less than 100% occupancy.

Councilmember Koss asked if this could be extended past December 31<sup>st</sup> to the end of February, 2021.

- \* **MOTION by Councilmember Boisvert; Seconded by Councilmember Koss, to extend outdoor seating for restaurants through February, 2021.**

**THE MOTION CARRIED UNANIMOUSLY (5-0)**

Assistant City Manager Fuhrer advised that the third item for consideration was social gatherings. He mentioned special event waivers and other plans in place for large events. There are a number of promoters interested in bringing back

concerts next year. Staff was seeking the requirement that safety plans continue to be submitted as well as bringing back in house approvals with the exceptions of street closures, and they would still seek COVID waivers.

Councilmember Boisvert believed that they should wait to the first of the year to make this decision, as this is still an unknown.

Assistant City Manager clarified that the safety plans would still be required they would just be approved at the staff level and explained what some of the events were. They could continue with the way they have been doing it but there are some who submit in a tight timeframe.

Councilmember Warner does not have a problem with smaller events being approved at staff level if they meet the criteria.

Councilmember Koss agreed.

Mayor Williams advised that the Space Coast League of Cities has cancelled the December meeting and he felt it would be nice to show appreciation to employees after everything that has gone on this year.

City Manager Whitten asked for that to be put in the form of a motion so that there were no misunderstandings and he agreed to bring back information regarding an employee recognition.

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COCOA, BREVARD COUNTY, FLORIDA; AMENDING CHAPTER 6, ARTICLE II OF THE CITY CODE, RELATING TO CODE ENFORCEMENT; CREATING A NEW LIEN AMNESTY PROGRAM; PROVIDING FOR THE REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, INCORPORATION INTO THE CODE, SEVERABILITY, AND AN EFFECTIVE DATE.**

Attorney Garganese mentioned that a final date would need to be entered into the ordinance.

Mayor Williams advised that he had an issue with Section d.2 and that if someone owned multiple properties and they have the opportunity to bring one at a time into compliance, it should be allowed, however, bringing them all into compliance at one time could be a bit of a stretch.

Discussion was held on this ordinance and for those with multiple properties.

Chief Cantaloupe added that this was designed for someone who may have received a lien several years ago and did not realize it, but now they want to upgrade or do an addition, but when you go to get a loan you find out there is a lien. This program is designed to help in those situations.

Deputy Mayor Goins asked that Ms. Senger really push this information out on social media so that people are aware. Secondly, he asked that when Code sends out letters with violations many do not understand them, so he suggested that pictures be included to help them better understand.

Chief Cantaloupe explained that before someone is cited Code will speak with the person and explain what they are being cited for. They have simplified the language and if they can make contact with the person they do a pre-notice. He assured Council that they would work on that and that he would have Ms. Martinez does a PSA from the Code Enforcement side as well.

Mayor Williams added that many did not know that the mobile vendor ordinance had passed. In response, Ms. Bunt announced that they had created flyers and have been handing those out to mobile vendors.



Attorney Garganese asked for clarification on the duration of the program. It was determined it would be for eighteen months.
