#### **RESOLUTION NO. 2020-234**

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COCOA, FLORIDA AUTHORIZING AND APPROVING THE COMPOSITE FORM OF MASTER RESOLUTION NO. 93-27; AND PROVIDING FOR AN EFFECTIVE DATE FOR THIS RESOLUTION.

WHEREAS, the City Council (the "City Council") of the City of Cocoa, Florida (the "City"), duly adopted Resolution No. 93-27, on August 18, 1993, which authorized the issuance of obligations of the City entitled City of Cocoa, Florida Water and Sewer System Revenue Bonds (the "Original Master Resolution"); and

WHEREAS, since the adoption of the Original Master Resolution by the City it has been amended and/or supplemented by Resolution 97-23 adopted on April 22, 1997; Resolution No. 98-2 adopted on January 13, 1998, Resolution No. 2007-44 adopted on May 8, 2007; Resolution No. 2009-104 adopted on September 8, 2009, Resolution No. 2009-105 adopted on September 8, 2009 and Resolution No. 2018-059 adopted on August 14, 2018 (collectively, the "Supplemental Resolutions"); and

**WHEREAS,** for efficiency purposes, the City desires to approve a Composite Form of Master Resolution which incorporates the terms of the Supplemental Resolutions into the Original Master Resolution in the form attached hereto as Exhibit A; and

# NOW BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COCOA, FLORIDA:

**SECTION 1. AUTHORITY FOR THIS RESOLUTION.** This Resolution is adopted pursuant to the provisions of the Constitution of the State of Florida, the Charter of the City, Chapter 166, Part II, Florida Statutes, as amended, and other applicable provisions of law.

**SECTION 2. FINDINGS.** The WHEREAS clauses recited above are hereby incorporated herein as a part of this Resolution.

**SECTION 3. APPROVAL OF COMPOSITE FORM OF MASTER RESOLUTION 93-27.** The City does hereby approve the form of the Composite Form of Master Resolution No. 93-27 attached hereto as Exhibit A.

**SECTION 4. GENERAL AUTHORITY.** The members of the City Council, the Mayor or Deputy Mayor, the Finance Director, the City Clerk and any designated Deputy Clerk and the officers, attorneys and other agents of the City are hereby authorized to do all acts and things required of them by this Resolution and the Original Master Resolution, for the full punctual and complete performance of all the terms, covenants and agreements contained herein, and each member of the City Council, attorney and officer of the City, the Mayor or Deputy Mayor, the Finance Director and the City Clerk and any designated Deputy Clerk is hereby authorized and directed to execute and deliver any and all papers and instruments and to be and cause to be

done any and all acts and things necessary or proper for carrying out the transactions contemplated hereunder.

**SECTION 5. SEVERABLILITY AND INVALID PROVISIONS.** If any one or more of the covenants, agreements or provisions herein contained shall be held contrary to any express provision of law or contrary to the policy or express law, though not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separable from the remaining covenants, agreements or provisions and shall in no way affect the validity of any of the other provisions hereof or of the Composite Form of Master Resolution 93-27.

**SECTION 6. EFFECTIVE DATE.** This Resolution shall take effect immediately upon its adoption.
