- Furnishing bid, performance, or payment bonds – if required, add 1.5% to overall contract value
- Bypass pumping or dewatering
- Traffic control or MOT
- Debris removal and/or disposal
- Non-weather related delays or delays outside of Vortex’s control
- Cementitious build back of the existing substrate beyond 3”. If required, this will be at an additional cost of \$10.00 sqft
- Pressure grouting
- Site clearing, excavation or restoration
- Permits or fees

- Customer to provide access for equipment within 50ft of structures
- Site access to be determined by physical inspection
- Customer to provide access to potable water supply
