## RESOLUTION NO. 2021-60

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COCOA, FLORIDA, ESTABLISHING THE ROLLED-BACK MILLAGE RATE; ADOPTING A PROPOSED TENTATIVE MILLAGE RATE; AND SETTING THE DATE, TIME AND PLACE OF A PUBLIC HEARING TO CONSIDER THE PROPOSED TENTATIVE MILLAGE RATE AND TENTATIVE **BUDGET FOR FISCAL YEAR 2022; PROVIDING FOR** THE REPEAL OF PRIOR **INCONSISTENT RESOLUTIONS**; AND **PROVIDING** FOR AN EFFECTIVE DATE.

**WHEREAS,** Florida Statute 200.065 expressly provides that municipalities shall adopt a Proposed Tentative Millage rate; and

WHEREAS, Florida Statute 200.065 requires that within 35 days of certification of value, each taxing authority shall advise the property appraiser of its proposed tentative millage rate, of its rolled-back millage rate and of the date, time and place at which public hearings will be held to consider the proposed tentative millage rate and tentative budget; and

**WHEREAS**, Florida Statute 200.65 provides that at the time of the adoption of the proposed tentative millage rate, the municipality shall set the date, time and place for a public hearing to consider the proposed tentative millage and the tentative budget; and

**WHEREAS,** Florida Statute 200.65 further requires that within 80 days of the certification of value, but not earlier than 65 days after the certification the governing body of each taxing authority shall hold a public hearing on the tentative budget and proposed tentative millage rate.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COCOA, as follows:

**SECTION 1.** The rolled-back millage rate to be used for millage calculation for the City of Cocoa, Florida for Fiscal Year 2022 is set at 5.8749 mils.

**SECTION 2.** The proposed tentative millage rate for the City of Cocoa, Florida for the Fiscal Year 2022 is 6.4532 mils which is 9.84% greater than the computed rolled-back rate of 5.8749

**SECTION 3.** A public hearing shall be held in the City of Cocoa City Council Chambers located at 65 Stone Street, Cocoa, Florida on September 14, 2021 at 6:00 p.m. to consider the proposed tentative millage rate and the tentative budget for Fiscal Year 2022.

**SECTION 4.** All prior resolutions or prior resolutions inconsistent with this resolution are hereby repealed to the extent of the conflict.

**SECTION 5.** This resolution shall become effective immediately upon its adoption by the City Council of the City of Cocoa, Florida including, but not limited to Resolution No. 2021-60.
