MINUTES City of Cocoa Regular Meeting of The City Council

February 23, 2021

A Regular City Council Meeting was held on Tuesday, February 23, 2021, in Cocoa City Hall, in City Council Chambers, located at 65 Stone Street, in Cocoa, Florida, 32922, as publicly noticed.

I. Opening Matters:

Mayor Blake called the meeting to order at 6:06 p.m.

Coach Snyder from Cocoa High School provided the invocation and the Cocoa High School Football Team led the assembly in the Pledge of Allegiance to the Flag of the United States of America.

The City Clerk took the roll.

- 1. Proclamation: Recognition of Cocoa High School Football Team. (21-104). (Mayor Blake)

Mayor Blake introduced the Cocoa High School Athletic Director Mark Carstens as well as Football Coach Snyder.

Mr. Carstens thanked the Mayor and all of those in attendance for recognizing the football team.

The team was invited forward and Councilmember Hearn read the proclamation into the record.

Deputy Mayor Goins read a statement from Principal Wilson who could not be in attendance.

2. Certificate of Recognition presentation to Cocoa Auto Salvage. (21-141). (Councilmember Dyal and Chief Lamm)

Chief Lamm recognized Cocoa Auto Salvage and explained what they provide to the City in order to aid the Fire Department. They donate materials of which the Fire Departments utilize during training. A Certificate of Recognition was presented to them.

Councilmember Dyal thanked the Lathem's for their constant support throughout the years.

IV. Delegations:

Theresa Clifton, 4990 Scarlett Drive, Cocoa, and Executive Director of the Central Brevard Humane Society, mentioned Mardi Paws in the Park event this Sunday, February 28, 2021. The event will begin at 3 p.m. and judges should be there by 12:30 p.m. She stressed that all COVID safety protocols would be met and animals should be leashed or in a cart and should have their tags on.

Jo Shim, 4010 Dakota Avenue, Cocoa, provided an update on the Mayor's Fitness Challenge. She thanked those who have participated so far and advised that there have been three events and 167 people who have registered. She urged everyone to log their minutes each week so that they are counted. March 13th is the next big event which will be held in Cocoa Village and will start at 9 a.m. People can still sign up.

Aleck Greenwood, 640 Brevard Avenue, Cocoa, thought that the Key to the City presentation for Jamel Dean was wonderful. He voiced concerns of the Commercial Property Group and thanked Mr. Smith for fixing the drainage issues by Travis Hardware. Lastly, he advised that he could not attend the last Council meeting and was upset that the Commercial Property Group was ignored in regards to the removal of crosswalks. He corrected the fact that was stated in that it was in regards to the design and does not want to be ignored again. Those were removed without the approval of Council until it was brought to Council's attention. He asked them to take notice and make a wrong a right.

Attorney Garganese read Ordinance No. 03-2021 into the record. He advised that this was the second and final reading. This includes the consideration of a final PUD and a Development Agreement.

ORDINANCE NO. 03-2021

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COCOA, BREVARD COUNTY, FLORIDA; AMENDING THE OFFICIAL ZONING MAP DESIGNATION OF ONE (1) PARCEL OF REAL PROPERTY, TOTALING 15.74 ACRES, MORE OR LESS, AND GENERALLY LOCATED ON STATE ROAD 524, DIRECTLY SOUTH OF STATE ROAD 528 AND WEST OF EAST INDUSTRY ROAD, IN COCOA, FLORIDA, MORE PARTICULARLY DEPICTED AND LEGALLY DESCRIBED ON EXHIBIT "A" ATTACHED HERETO, FROM GENERAL COMMERCIAL (CG) TO PLANNED UNIT DEVELOPMENT (PUD); PROVIDING FOR THE REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, SEVERABILITY, AND AN EFFECTIVE DATE.

Ms. Selig provided a presentation¹ on the proposed development and explained that there are two phases in the redevelopment of the old Winn Dixie store. There is a rezoning, a binding development agreement, a PUD, a large scale siteplan, and a preliminary subdivision, all being approved tonight.

The project location was shown as well as a site plan layout.

A project summary was explained in detail, including the scopes of Phase 1 and Phase 2. The amenities were spoke about as well.

She provided staff's recommendation and conditions if approved.

Ms. Selig advised that the applicant was in attendance and would like to say a few words.

Marilyn Healy, 401 E. Jackson St., in Tampa, Florida mentioned that this project had been a work in progress over the last two years. This is a prime infill development for the City. She thanked Council on behalf of herself and the developer, along with Mr. Whitten, Ms. Selig and staff. It is a very complicated project and staff has guided them along the way and was a huge help throughout the process. She assured Council that they could continue to communicate throughout the development. She introduced other members of their team.

Mr. Herring spoke on behalf of the project and noted that this was coming to an end of a long road with the pre-development process. This is a fantastic location and will be beneficial to the City. Framework Group is housed in Tampa and take a big approach to all of their projects. He further mentioned the plans for the

apartments and spoke of all the amenities. They are ready to start as soon as they are able.

Councilmember Koss commended them on the smart growth principals and mentioned infill, mixed land use, and creating a walkable neighborhood.

Mayor Blake thanked them for choosing Cocoa. He appreciated the amenities and them working positively and collaborating with the City Manager. It will provide District 3 with their own identity and he congratulated all.

Councilmember Dyal felt that the modern look would work well and will brighten and lift up the whole area.

Mayor Blake closed the portion of the hearing to Council and opened it up to the public.

Alec Greenwood, 630 Brevard Avenue and a member of the Planning & Zoning Board pointed out that he was 100% in support of this project.

There being no further response, Mayor Blake closed the public portion of the hearing.

- 3. Revise landscape plans to increase 4 trees from 2.5" to 4" d.b.h at planting and increase 1 tree from 2.5" to 6" d.b.h at planting.
- 4. Change the proposed grade on the west banks of the swale between Coventry and the site to state they will be regraded to a minimum height of 6" above the existing control structure #2 rim.

City Manager Whitten acknowledged the hard work of staff over the last three months as well as the City Attorney. Without them they would not be where we are at this point.

City Clerk Shealy added that after the agenda was published it was requested that the second meeting of November be cancelled due to the Thanksgiving holidays. However, there are financial items that by law, have to be approved by November 30th. Staff was requesting to cancel the November 23rd meeting and hold a Special meeting on November 30, 2021.

Ms. Bunt explained the history of these resolutions and that they were enacted due to Covid-19. This Resolution would extend the expiration date of the most recent Resolution No. 2020-146.

Deputy Mayor Goins asked if this could be made into a law so that they did not have to come back to council for reapproval. He believes it is nice to see people dining outside.

In response to his question, Attorney Garganese mentioned that an ordinance could be presented in the future but this was an emergency resolution due to Covid-19.

Councilmember Koss agreed that outdoor seating makes people more comfortable and would like to see it continue as well.

Ms. Bunt further explained that Dog N' Bone uses Myrt Tharpe Gazebo and the Village Idiot and Pub Americana use public parking for outdoor seating so they need to consider that in the future.

City Attorney Garganese advised that those issues could be evaluated and it could be brought back for a permanent code change.

City Manager Whitten agreed with the City Attorney.

VIII. City Business:

1. City staff is seeking approval to enter into a new solid waste franchise agreement with Waste Management Inc. of Florida for solid waste services for customers within the incorporated City of Cocoa. (21-162). (Public Works Director)

Mr. Smith reminded Council that at their last meeting they directed staff to continue negotiations with Waste Management for two weeks.

Dina Reider-Hicks, Waste Management, 3303 Lake Drive, Cocoa, thanked Council for their support and noted that they have had a strong relationship with Cocoa. Mr. Smith and City Manager Whitten have worked with them to develop a solid plan with the lowest price possible. She thanked them again for considering the request and for their trust in Waste Management.

Joanne Stanley, Republic Services, 2575 Doreatha Field Avenue NE, Palm Bay, advised that what was attached to the agenda item was a contract with West

Melbourne. She asked if they would go out for a bid or would they have a new contract with Waste Management. She further asked if green waste would be brought in house.

Quentin L. Brown, 1245 Marshall Court, Merritt Island, spoke as an employee of Waste Management and mentioned how proud he was to work for them. He takes pride in what he does and all of Waste Management's decisions have always benefited him and others and they all take pride in working for them.

Deputy Mayor Goins knew Mr. Brown and stated he was proud of him and was glad to see how much the company is represented. He appreciated him coming.

George Geletko, Waste Management, mentioned there were two things here. One was to either go out for bid or to renew negotiations. He provided an example of each and noted the same process was done in Palm Bay one year ago. He explained the process and that it worked out. They are appreciative of the City and are honored to serve the citizens of Cocoa for the last several years.

Mayor Blake was aware there was an issue with green waste but feels that a solution had been found and that there was some wiggle room in regards to that. Secondly, he announced that several of his friends and former students work for Waste Management. He knows the quality of work that Mr. Brown eluded to earlier. Lastly, he knows that a lot of work was put into this and supported staff entering into a new agreement.

X. Reports:

Chief Lamm provided an update on COVID-19, and mentioned that in the State of Florida there are currently 1,872,923 cases; in Brevard County there are 33,106 and 728 deaths; in Cocoa there are 3,026 cases with 28 active cases in the City limits. They are starting to see a downward trend both nationally and in Florida.

Secondly, he provided a report on vaccines and advised that 78,538 had been given in Brevard County so far. They are continuing to work with the County as far as allocations when vaccines come into the county. They are not getting many but are continuing to push out signups.

He thanked Lisa Lathem, Linda Dolphin and Jennifer Riggs for volunteering their time to assist with vaccine registrations for those who do not have a way to do so.

Chief Lamm announced that earlier in the week the Space Coast Fire Chief Awards were announced and Lt. Justiniano was recognized as Company Officer of the Year. He congratulated him.

Lastly, Chief Lamm spoke about an incident in Rockledge that happened on February 11, 2021. It was a horrific accident at Murrell and Eyster with two vehicles involved. Chief Wilson from Rockledge Fire Department was the first rescue unit on the scene and when he arrived, Driver Matt Holladay with Cocoa Fire Department was inside the vehicle and was able to assist and provide a full description of what had happened. He also went to the other vehicle and stayed with the patient until other units arrived. He was off duty and disregarded what was going on but put service above himself and provided aide no matter where it was at. Fire Fighter Holladay's extraordinary actions made a difference that day and he commended him.

City Manager Whitten pointed out the cancellation of the February 25th and March 15th workshops and stated they were working to reschedule those.

Lastly, he thanked the following staff members for their time and work in regards to the Waste Management negotiations: Matt Fuhrer, Rebecca Bowman, Bryant Smith, and Anthony Garganese. He stressed it was a team effort.

Councilmember Hearn thanked Council and staff for the Key to the City presentation to Jamel Dean. He received a lot of good feedback and felt it was good for both him and the City.

Councilmember Hearn further mentioned that the Carl Anderson Park cleanup was completed and he took his kids there to play. They enjoyed it and he thanked staff and Brevard County Parks and Recreation.

He had a walk in his district yesterday for the Mayors Fitness Challenge and they will be at Bracco Park on March 6th at 10 am.

Lastly, he advised that he spoke with Mr. Smith regarding speeding in the North Carolina Avenue area. They are looking for solutions to try to slow down some of those speeders.

Councilmember Koss mentioned that the Brevard Museum of History and Natural Science will be closing on March 1st and coming back into the City's hands. She advised that March 13th is a tentative date for meeting to discuss ways to bring that neighborhood back as it is the academic hub of Cocoa.

She further spoke about the Citizen's Academy and how it has developed. It is generating volunteers and felt was great to see it evolving. She is interested in opening up as many ways to volunteer as possible.

Councilmember Koss stated that she would like to look at term limits for board members and asked the City Manager to put an item regarding this on an upcoming agenda.

She believed that as representatives they should have eight-year term limits and thought it would be good for volunteers to move around to get more experience.

Lastly, in the current Quality Cities magazine there was an article about former Mayor Jake Williams, Jr. She was glad to see that he was acknowledged and he would be honored at the Emma Jewel Black History program on February 25, 2021.

Councilmember Dyal thanked Deputy Mayor Goins for the Key to the City and thought it was fantastic. Additionally, he mentioned the walk he did on February 18th behind the Museum and was looking forward to Mardi Gras this upcoming Saturday night.

Mayor Blake was glad that Deputy Mayor Goins had the ability to get the event together and to communicate with Mr. Dean's family. He thought it was a great event as well.

Deputy Mayor Goins announced he and Councilmember Koss would be attending the Institute for Elected Municipal Officials class (IEMO) on April 23-24, 2021 at the Hilton in Daytona Beach, Florida.

He asked Mr. Smith for an update on the Broadmoor Acres stormwater project. In response, Mr. Smith advised that the last piece of documentation for that project was in FEMA's hands now. They should be notified in the near future. They worked for about a year with the Army Corp for a permit.

Deputy Mayor Goins stated that Council members represent not only their own district but all of Cocoa. They all care about Cocoa.

He spoke of his appreciation for staff for the short notice of the Key to the City presentation. It was pulled together quickly and if you are doing it for the right reason it will come together like it should. He thanked everyone again.

Deputy Mayor Goins announced the Mayor's Fitness Challenge walk in Cocoa Village with St. Marks Episcopal Academy on March 12th. There will be another walk on March 13th in the Village at 9 a.m. and then one will be done in the Diamond Square area (at the pond behind Emma Jewel Charter Academy) on March 20th at 9 a.m.

He recognized Curtis Palmer in the audience who is responsible for bringing the BB&T Potential Homebuyer Program to the City and Ms. Mark who is in the gifted program at McNair Magnet School.

Mayor Blake recognized Ms. Sharon Spikes for being recognized in the Trail Blazer's article in the Space Coast Living Magazine and commended her for all that she does in the community.

Ms. Spivey thanked the Mayor and stated it was an honor to be here and to be recognized. She advised that she does what she does out of love.

Mayor Blake further mentioned the Cocoa High School art students who provided gift bags to the Cocoa PD and thanked them.

Mayor Blake apologized to Councilmember Hearn for an error he made at the Town Hall meeting regarding District 2 intersecting Broadmoor Acres. It is all Team Cocoa and he thanked Councilmember Hearn.

He requested ten pallets of water to be donated to Houston, Texas, like the City did for Flint, Michigan in 2016. He asked for a consensus from Council on this request.

* MOTION by Councilmember Dyal; Seconded by Councilmember Hearn, to donate ten pallets of water to Houston, Texas.

Mayor Blake further addressed the FBI investigation and asked the City Attorney, City Manager and staff what could be done in order to address this if it exists and what could be done.

In response, City Manager Whitten advised that he spoke with the representative that City staff had spoken to earlier. The position of the FBI was to not comment on whether there is or is not one.

He advised that one comment he could provide was that no one from the FBI has contacted him or staff regarding the allegations.

Mayor Blake asked if a press release could be done because people are asking questions and he does not want it to be a hinderance. He wants things to improve and be in collaboration with everyone. He asked how that can be done.

City Manager Whitten stated that he could put out a statement stating what he previously stated, that he nor staff has been contacted so they are unaware of any investigation that may or may not be ongoing. He has been here since October 9, 2020 and has not been presented with any allegations of wrongdoing by staff. Spirits are high, we just need to get more workshops done. The FBI is not going to comment either way.

Mayor Blake spoke about the acreage on Rosa L. Jones and would like the item brought back. This project needs to be done.

City Manager Whitten advised that staff was in the process of bringing back the item. It is being presenting to the developer, but regardless, it has to come back to Council.









Exhibit B - Site Plan layout


