Approve the revised street closure request for the Spring Car Show on April 10, 2021.

BACKGROUND:

During any given calendar year, the number of street closures approved by the City Council within the Central Business District (CBD) zoning district shall not exceed twenty-four (24) days. Any street closure lasting in excess of four (4) hours shall be counted as one full day, while any street closure of four (4) hours or less shall be counted as one half day per the Special Events Ordinance No. 04-2018.

On January 12, 2021, Cocoa City Council approved the list of upcoming street closures for the 2021 calendar year. On this agenda item was the request for the street closure for the Historic Cocoa Village Main Street (HCVMS) Spring Car Show which was being held in conjunction with the Crosswinds Duck Race. Crosswinds has decided to hold their annual event virtually this year and so HCVMS would like to switch their car show date to April 10, 2021. See below for original closure information and revised closure information. Closure will still be a one day closure with the total amount of street closures for the year totaling 23.5 days.
